MEMBER/CHILDREN RELEASE and WAIVER of LIABILITY and INDEMNITY AGREEMENT

IN CONSIDERATION of being permitted to utilize Park Colony Club ("Swim & Tennis Club") for any use of the services and facilities at the Swim & Tennis Club, included but not limited to the swimming pool, playground, basketball courts, volleyball courts, tennis courts and grounds, the undersigned, for himself or herself and such participating minors ("children") and any personal representatives, heirs, and next of kin, hereby acknowledges, agrees and represents that he or she has, or immediately upon entering will inspect and carefully consider such premises and facilities. It is further warranted that such entry into Park Colony Club for observation or use of any facilities or equipment or participation in such programs at Park Colony Club constitutes an acknowledgement that such premises and all facilities and equipment thereon and such programs have been inspected and carefully considered and that the undersigned finds and accepts same as being safe and reasonably suited for the purpose of such observation, use or participation by the undersigned and such children.

THE UNDERSIGNED HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS the SWIM & TENNIS CLUB and its elected board members, directors, management, staff, servants, agents, employees and/or independent contractors from any and all claims, losses and liabilities arising from, connected to, and/or arising from the undersigned or such children's use of the services and facilities at Park Colony Swim & Tennis Club, included but not limited to the swimming pool, playground, basketball courts, volleyball courts, tennis courts and grounds.

THE UNDERSIGNED ON HIS OR HER BEHALF AND BEHALF OF SUCH CHILDREN declare and affirm that THE UNDERSIGNED AND SUCH CHILDREN are in good medical and physical condition, and use of the services and facilities at Park Colony Swim & Tennis Club does not pose any danger to the undersigned or such children's health. The undersigned and such children further agree to abide by the rules and regulations of the Swim & Tennis Club, as they now exist or may be amended at the discretion of the Swim & Tennis Club.

THE UNDERSIGNED further expressly agrees that the foregoing RELEASE WAIVER AND INDEMNITY AGREEMENT is intended to be as broad and inclusive as is permitted by the law of the State of Michigan and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
